Dynamics Dance Project Financial Obligation Form

Tuition is paid monthly. Payments are due at the 1st of every month, however, there is a 5-day grace period. Any fees not paid by the 6th of the month will have a \$15.00 late fee added to their bill. Payments can be made via Zoho (CC with an additional fee), cash, or check. Cash and check payments can be made in the black box in the office. Receipts will be sent by email after the payment is posted.

Checks should be made out to Dynamics Dance Project. There is a service fee for each returned check

What is Zoho?

Everyone will receive a link to access the Zoho portal. Zoho is a parent portal where you can view your invoices, due dates, and make CC/debit card payments. Please notify us immediately if you'd like to have the ability to make payments through Zoho, so we can add that feature to your account. There is an additional charge for making payments by CC/debit card.

There are NO refunds or pro-rates on tuition.
